



SUMMER DANCE CAMP

HOURS OF OPERATION

Monday-Friday

*9:00am-4:00pm (*Extended Care available from 8:00am-5:00pm for an additional \$20/week)

FORMS NEEDED TO REGISTER

The following must be completed and provided to FBAAD at time of registration. On the first day of camp, parents must be present at drop-off to ensure all forms are completed:

1. Signed Parent Handbook
2. Camp Session(s) and Tuition Payment

PAYMENT

\$99.00 Weekly Session Fee + \$20 Weekly Activity Fee

Registration Fee: \$25 Single Camper/\$40 Family Campers

Full payment is due at time of registration.

Session fees are due the Friday before the next session.

Session fees paid after Monday will be charged a \$25 late fee. A \$25 late fee will be assessed per child, not per family!

We accept Zelle, CashApp, Paypal, Cash, and Check payable to FBAAD. Camper fees provide for FBAAD-trained staff, transportation, equipment, supplies, program insurance, admission for field trips/activities, and professional staff leadership.

\$25 DAILY FEE FOR CAMP! NO CREDITS GIVEN FOR WEEKS PAID AND NOT USED!

Space availability for weekly sessions are NOT GUARANTEED unless an advance/non-refundable deposit of \$25 has been made or the weekly session is paid in full. Paying the weekly deposit or full amount in advance of each weekly session you would like your child to attend is strongly recommended.

DROP-OFF AND PICK-UP/LATE POLICY

Late fees apply to those who arrive after 4:00pm. If you are going to be late, please call the camp and inform a FBAAD staff member (fees still apply). The fee is \$5 for the first 15 minutes (4:01pm-4:15pm) and \$1 per min thereafter. The late pick-up fee is due when you arrive to pick up your child; NO EXCEPTIONS.

Extended care drop-off begins at 8:00am (camp will not open earlier than 8:00am), and extended pick-up must happen before 5:00pm. The above late fees apply after 5:00pm as well.

MEDICATION

FBAAD will not administer medication. Parents should administer medication prior to drop -off or after pick-up.

LUNCH

Campers must bring daily lunch, AM/PM snacks, and drinks. Freezing drinks the night before helps to keep everything cool

all day.

SWIM DAYS/CAMP DAYS

On swim days, campers should bring a swimsuit and a towel. Campers may also bring sunscreen, a hat, sunglasses, and bug spray daily. Campers must wear tennis shoes. The best way for campers to keep their gear together is with a labeled backpack. Please label all personal items your child brings to camp! Campers ARE NOT ALLOWED to bring radios, game boys, MP3's, IPOD's, or any items of value to camp. FBAAD will not be responsible for any lost, stolen, or broken items that your child brings from home.

CONDUCT/FIELD TRIP POLICIES

A camper may be suspended or released from camp, without refund, for the following misconduct while participating in the Summer Dance Camp and/or being transported: Stealing, fighting, using foul language, or abusive behavior; defacing FBAAD property, another child's property, or vehicles; being rude and discourteous to FBAAD staff or to others; not remaining seated at all times, not keeping the seat belt fastened while in transport, if applicable, and/or having any body part out of the window.
